First Article Test (FAT) units submitted to H.P. White Laboratories, Inc. for contractor sponsored testing for the below listed designs are hereby approved.

The designs for which FAT units were submitted, MP2S1, GP2S1, C3P2S1, and K3P2S1, were previously subjected to First Article Testing, passed requirements, and were authorized for production under these contracts as referenced in the following: letter no. 543 dtd 11 Jan 07 (MP2S1), letter no. 599 dtd 8 Feb 07 (GP2S1), letter no. 649 dtd 27 Feb 07 (C3P2S1), and letter no. 1152 dtd 18 Jan 07 (K3P2S1).

New FAT units of these previously approved designs were submitted for testing to validate production using a new larger capacity autoclave that was recently installed in the Armorworks production facility. Approval is based on an analysis of FAT test data provided to the Government under report numbers HPWLI 10556-92A (MP2S1), HPWLI 10556-98A (GP2S1), HPWLI 10556-99A (C3P2S1), HPWLI 10556-97A (K3P2S1) and the recommendation of the Project Engineer.

Based on the FAT results for the items submitted, designs produced using the new autoclave have the capability to meet the performance requirements for Enhanced S-SAPI set forth in CO/PD 06-20 under the subject contracts.


